Dean's Order No.6/2022 of the Joint Order of the Rector - Chancellor - President of the University of Pécs's Clinical Centre on the implementation of the higher education related educational organisation objectives of the Faculty of Health Sciences in the spring semester of the academic year 2022/2023, on the measures aimed at reducing the utility costs of the University of Pécs

PREAMBULUM

Due to the significant increase in energy prices, considering the provisions of the Government Decree No. 368/2022 (IX. 29.) on the emergency rules applicable to the academic year 2022/2023, the University of Pécs has adopted the Decree No. based on the joint Order of the Rector, Chancellor, and President of the Clinical Centre (hereinafter referred to as the Order), I hereby regulate the issues of the organisation of teaching for the spring semester of the academic year 2022/2023 of the Faculty of Health Sciences concerning the realisation of cost-saving objectives as follows.

§ 1 [Scope of the Dean's Order]

(1) The personal scope of this Dean's Order extends to all courses at the Faculty (higher education vocational training, bachelor's degree, master's degree, specialised further education, doctoral studies), regardless of nationality, to all persons participating in such courses and having a student status with the University (hereinafter referred to as students), as well as to employees and other persons having employment relationships with the Faculty.

(2) This Dean's Order is valid for the spring semester of the academic year 2022/2023.

§ 2 [Order of the academic year]

(1) The timetable for the academic year is amended as follows.

a) the registration week and the training period will run from 30 January 2023 to 19 May 2023;

b) the previously planned spring break (11 April 2023 - 14 April 2023) will be rescheduled to 6-10 February 2023;

c) the examination period may be organised between 22 May 2023 and 23 June 2023;

(d) the examination period for those eligible to sit the final examination may be organised between 26 April 2023 and 10 May 2023;

(e) the final examination period is from 16 May 2023 to 9 June 2023.

(2) From the registration week of the spring semester (30 January 2023 - 3 February 2023), theoretical education may be conducted in a hybrid form for students on correspondence courses and for full-time students who are studying in their last semester, and hospital/field placements may be organised for these students.

(3) During the 4th and 5th week of the spring semester, full-time students who are not studying in the last semester may receive theoretical education in a hybrid form and may also be offered an in-service hospital/field placement.

(4) From the 6th week of the spring semester (from 6 March 2023), theoretical and demonstration hall practical training will be in the form of attendance.

(5) Deviations from the provisions of these Regulations set out in paragraphs (1) to (4) of Article 2 may be made only with the written permission of the Dean, after informing the student body concerned without delay and in consultation with the student government.

(6) During the examination period for the spring semester, which is the period for the completion of the advanced examination courses, the examinations are organised in a hybrid framework, except for the practical and face-to-face examinations. The instructor of the course concerned will inform the students concerned in advance of the form in which the hybrid examination will be held.

(7) For the purposes of this Order, hybrid Order consists of contact hours or equivalent electronic distance education requiring face-to-face attendance for the course. The rules for the part of the hybrid examination system not requiring face-to-face attendance are set out in The provisions of Chapter 12 of the PTE Study and Examination Regulations on the organisation of examinations shall apply.

(8) This Dean's Order may be amended in the event of any changes to the spring semester schedule, based on the guidance of the sectoral governing ministry or the Rector.

§ 3 [Entry into force and final provisions]

This Order shall enter into force on 30 January 2023 and shall be without further action shall expire on 23 June 2023.
